#### 2.0 PURPOSE OF REPORT

This document is the second Annual Compliance Report for EPBC approval 2015/7436, for the year of 2024-2025. This was granted to Arafura Resources Limited (now operating as Arafura Rare Earths Ltd, hereafter referred to as Arafura) on 11 May 2018 under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act) (the Original Approval) for the Nolans Rare Earth Project (the Project).

The Original Approval was revised, resulting in variations to the conditions, and reissued on 24 October 2024 (the Revised Approval), during the 2024-2025 reporting period. Condition 11 of the Original Approval which governed the annual compliance report, was revoked and replaced by Condition 35 in the Revised Approval. The wording of Condition 11 of the Original Approval and Condition 35 of the Revised Approval are presented below.

Condition 11 of the EPBC Original Approval:

Within three months of every 12-month anniversary of the commencement of the action, the approval holder must publish a report on their website addressing compliance with each of the conditions of this approval, including implementation of the management plans as specified in the conditions. Documentary evidence providing proof of the date of publication and non-compliance with any of the conditions of this approval must be provided to the Department at the same time as the compliance report is published.

The commencement of the action was 27 February 2023, therefore the reporting period under the Original Approval was 27 February to 26 February each year.

Condition 35 of the EPBC Revised Approval:

The approval holder must prepare a **compliance report** for each **Annual Compliance Report** *period* (ACR period).

Part C of the Revised Approval – Definitions:

**Annual Compliance Report period** or **ACR** period means each subsequent 12-month period following the date of this approval decision until the expiry date of this approval, unless otherwise specified in writing by the **Minister**.

The date of the Original Approval decision was 11 May 2018, therefore the reporting period under the Revised Approval is 11 May to 10 May each year.

This compliance report (2024-2025) addresses the compliance of the conditions in both the Original Approval and the Revised Approval for the dates each respective approval was valid. As the Revised Approval was issued during the reporting period, the Original Approval is reported against for the period of 27 February 2027 until 23 October 2024; and the Revised Approval is reported against for the period of 24 October until 10 May. As a result, the reporting period is longer than the usual 12-month period in this case. For the next reporting period (2025-2026) the regular 12-month reporting cadence of 11 May to 10 May will commence and be ongoing.

This report has been prepared in accordance with the *Annual Compliance Report Guidelines, Commonwealth of Australia 2023* (the Guidelines), as outlined in Condition 37 of the Revised Approval, shown below.



Condition 37 of the EPBC revised Approval:

The approval holder must ensure each compliance report is completed to the satisfaction of the Minister and is consistent with the Annual Compliance Report Guidelines, Commonwealth of Australia 2023.

As noted above, Arafura was issued a variation to the EPBC 2015/7436 approval on 24 October 2024. This variation followed a request submitted to the Commonwealth Department of Climate Change, Energy, the Environment, and Water (DCCEEW, the Department) on 25 March 2024 to amend Condition 8 of the Original Approval. The variation allows for the phased approval of Environmental Management Plans (EMPs) required under Conditions 2, 3, 4, 5, and 7 of the Original Approval, prior to the commencement of construction and/or specific activities. This now stages the approval of the required management plans before the commencement of the relevant activities.



## 3.0 ACTIVITY SUMMARY

Construction activities (the Action) at the Project site commenced with early construction works on 27 February 2023 and continued until mid-October 2023, when operations were temporarily suspended. Works have not recommenced since that time; hence no construction or others work activities were carried out at the Project site during the reporting period.

Since mid-October 2023, onsite activities have focused on continuing to collect baseline monitoring data to meet the environmental requirements outlined in the approved management plans. As well as site security and maintenance activities.

Full construction and resumption of the action is expected to proceed once the necessary approvals and financing are secured, and the Final Investment Decision (FID) is announced.



#### 4.0 DESIGNATION OF COMPLIANCE

A compliance table has been prepared for both the Original Approval (Table 5—1) valid until 23 October 2024; and the Revised Approval (Table 5—2) valid from 24 October 2024 onwards (refer to Section 5.0). Each approval condition has been assigned a compliance status in accordance with the Guidelines, as detailed in Table 4—1 below.

#### 6.0 IMPLEMENTATION OF ENVIRONMENTAL MANAGEMENT PLANS

As detailed in Section 5.0 above, there are five (5) EMPs required under the conditions of approval for EPBC 2015/7436, in both the Original and Revised Approval. A summary of the status of the five required EMPs is provided in Table 6—1 below. To date, two of these EMPs have been approved by the Minister, and were implemented during the reporting period, as detailed below.

The commencement of the action and completion of early site works at the Project site in the previous reporting period 'activated' the Biodiversity Management Plan (BMP) and Water Abstraction Management Plan (WAMP) - due to the site clearing works and water abstraction from bores undertaken.

As described in Section 3.0, early construction works were completed over an approximate 8-month period from 27 February to mid-October 2023. Limited water abstraction was undertaken during this time, over 3 months from 08 August to 27 October 2023, concurrent with grant of the groundwater extraction licence for the borefield on 08 August 2023.

No further site construction work or water abstraction has been undertaken since mid-October 2023, hence no activities associated with the action were completed during the current reporting period. The Project is awaiting FID to recommence construction activities.

As a result, during the reporting period Arafura focused on carrying out its ongoing environmental monitoring program to collect baseline data – with implementation of the monitoring requirements stipulated within the BMP and WAMP. It is anticipated the extended baseline data will be useful as a comparison point for environmental impact assessment during the construction and operational phases.

The following Table 6—2 details the implementation of the above-mentioned management plans during the reporting period. Commentary is provided regarding implementation and observations from the monitoring.

No 'Events' occurred during the reporting period as defined within the Revised Approval (including no potential or actual non-compliances with the conditions of approval; or environmental incidents resulting in potential or actual harm to a protected matter).
